Firms/Persons interested to buy the aforesaid vehicle are required to submit their highest quotations in the enclosed proforma addressed to the Under Secretary (Ad.III), Room No. 2, Ministry of Home Affairs, North Block, New Delhi – 110001 and **dropped in the Tender Box of this Ministry in Hall No. 2, Jalebi Chowk, North Block, New Delhi – 110001 on latest by 30.05.2018 at 3.00PM.** The sealed quotations received will be opened on **30.05.2018 at 3.30PM** at Room No. 2A, North Block, New Delhi. The vehicles are available for inspection from 11.00 AM to 3.00 PM on all working days.

The Bidders may drop their original bids/application alongwith an Earnest Money of **Rs.10,000/-** by way of Demand Draft in favour of "DDO, Ministry of Home Affairs, North Block, New Delhi-110001 in the Tender Box of this Ministry in Hall No.2, Jalebi Chowk, North Block latest by **30.05.2018 at 2.00PM.** The Bidders or their representative (not more than one) may be present, if they so desire, at time of opening of quotations.

4. The auction will be governed by the following conditions: -

(i) The successful bidder will be required to deposit the balance bid amount after deducting earnest money of Rs.10,000/- latest within one week of intimation about successful bidder by way of Demand Draft in favour of "DDO", Ministry of Home Affairs, North Block, New Delhi – 110001". *John*

(ii) The delivery of the sold vehicle will be given only to successful H-1 bidder after submission of documentary evidence in support of residential status (Ration Card/Voter Identity Card /Adhar Card in case of individual and Registration Certificates in case of firms etc.)

(iii) The sold vehicle shall have to be removed by the successful bidder immediately at his own expenses.


(iv) The vehicle will be disposed off on "as is where is basis" and no guarantee for its worthiness or quality will be given by this Ministry.
