

**“Expression of Interest (EOI)”**

Subject:- **Regarding revision of Qualitative Requirements (QRs) /Specifications of Light Category of Bullet Proof Vehicle (LBPV – Combat Variant).**

CRPF intends to procure Light Category of Bullet Proof Vehicle (LBPV – Combat Variant). Accordingly, revised draft Qualitative Requirements (QRs)/Specifications of Light Category of Bullet Proof Vehicle (LBPV – Combat Variant) have been formulated by a sub-group of technical experts. All interested bonafied firms/OEMs/manufacturers of Armoured Vehicles are required to go through these revised QRs and offer their valuable comments on the same, if any, so that to formulate generic, realistic, broad based and achievable QRs/Specifications of Light Category of Bullet Proof Vehicle (LBPV – Combat Variant).

2. As the construction of Bullet proof materials and armouring of vehicles etc. are covered under compulsory licensing under the Industries (Development and Regulation-IDR ) Act 1951 and also included as entry no.13 of schedule II of notification No. S.O. 477 (E) Dated 25<sup>th</sup> July 1991 & No. 7(3)/2009-IP.Vol IV dated 01/01/2019, therefore, being a sensitive nature item, the subject revision of QRs/specifications would be handed over (in hard copy) to only those concerned firms having Department of Industrial Policy & Promotion ( DIPP ) license duly obtained from Govt. of India, Ministry of Commerce & Industry for the subject purpose and are in a position to undertake all India After Sales, Service, Maintenance and Repairs, particularly in North East Region, LWE affected States and Jammu/Kashmir/Leh-Ladakh and market support and set-up for service, repair & maintenance, manufacturing and supply of essential spares, materials, guarantee warrantee and other requirements etc.

3. The subject revised draft QRs/Specifications will be handed over to interested eligible firms on the written request made by them on their official letter head and signed by either head of the division or equivalent officer authorized for doing so. The representative (not below the rank of concerned senior level officer working with the concerned division) of eligible firms detailed for collection of subject revised draft QRs/Specifications shall bring duly filled authority letter attached as Appendix-“A”.

4. Accordingly, interested OEMs/Firms may depute a suitable representative from their firm to collect the subject revised draft QRs/Specifications from O/O DIG (MT), Provisioning Dte. CRPF Directorate, Block No-1, CGO Complex, New Delhi-110003 (E-mail- [digmt@crpf.gov.in](mailto:digmt@crpf.gov.in), Phone/Fax-011-24360155) from **18/10/2021** to **25/10/2021** on any working day between **1000 Hrs to 1700 Hrs**.

5. The views/comments/representation ( if any) by the firm(s) on the parameters of revised draft QRs/Specifications may be submitted in hard copy in sealed cover to DIG (MT), Dte. CRPF, Block No-1, CGO Complex, Lodhi Road, New Delhi-110003 latest by **08/11/2021** for further needful action.

6. The response received after **08/11/2021** will not be taken into account and will not be considered”.
