Subject: Ex-gratia relief to the NoKs of J&K Police personnel killed in terrorism related incidents

Sir,

The above matter was considered by this Department and it has been decided at the level of Home Minister that the Centre may make ex-gratia payment of Rs.3.00 lakhs (Rupees three lakhs only) to the NoK of J&K Police personnel killed in terrorism related incidents, w.e.f. 1<sup>st</sup> March 2001.

2. The terms and conditions of this Scheme would be as under –

- (i) that the Central Government will make payment of Rs.3.00 lakhs (Rupees three lakhs only) to the NoKs of each personnel of J&K Police only killed in terrorism related incidents, over and above the amount of Rs.2.00 lakhs being paid by the State Government and reimbursed from SRE at present.
- (ii) the expenditure will be debitable to Major Head 2055 – Police, 00.113 Welfare of Police Personnel (Major Head) 00.00.31 – Grant-in-aid Contribution under Grant No.47 – Non-Plan.
- (iii) the payment would be made through a Demand draft, to be prepared by the Pay & Accounts Office of MHA, to the NoKs and the Demand Draft would be handed over to the NoKs by the IG/DIG/Comdt of the CPMF which is located near the place of the residence of NoKs in the presence of the local SP/Police officials who will identify the NoKs.

- (iv) The onus of correct identification of NoKs of JK Police personnel will clearly rest on the State Government of J&K.
- (v) the payment would be made on the basis of receipt of certificate from the Secretary, Home Department, Government of J&K, certifying the death and the terrorism related incident as well as identifying the NoK in a very clear terms. The Certificate is to be sent, along with the documents on the basis of which the State Government makes payment of Rs.2.00 lakhs as ex-gratia relief.
- (vi) the Demand Draft, to be prepared by the PAO, MHA on the basis of Sanction issued by the Department of J&K Affairs, would be sent to the Department of J&K Affairs, which in turn would send it to the ADG, CRPF, Srinagar, who would ensure the delivery of the Demand Draft through the IG/DIG/Comdt. Of the CPMF which is located near the place of the residence of NoK in the presence of the local District Superintendent of Police.
- (vii) a formal receipt of the Demand Draft may be obtained from the specific NoK by the concerned Authority of CPMF and thereafter forwarded to this Department, in original.
- (viii) Sanction would be issued on a monthly basis.

3. The State Government is requested to extend its fullest support for the smooth implementation of the Scheme and to forward all the desired documents to the Department, on a monthly basis, by adhering to the above guidelines.

4. This issues with the concurrence of the Internal Finance Division of MHA, vide their Dy.No.2200/FA(H)/2001 dated 14.5.2001.
