Vide this office GTE of even No. dated 21.12.2018 bids were invited for procurement of (i) RT PCR Qty. 08 Units of one each at (i) Bhopal (ii) Guwahati (iii) Kolkata (iv) Pune and (v) Four units at CFSL Chandigarh of DFSS. In this GTE 03 firms (i) M/s Invitrogen Bio Services India, Pvt. Ltd., (ii) M/s Qiagen, India Pvt. Ltd., and (iii) M/s Hi Media Laboratories Pvt. Ltd., participated. Only One firm i.e M/s Invitrogen Bio Services India, Pvt. Ltd., qualified in the TEC for the subject item i.e RT PCR. Above reference GTE for item at S.No. (i) RT PCR-Qty.08 Units is hereby scrapped with the following remarks:-

- (i) The Quoted price by the L-1 firm M/s Invitrogen Bio Services India, Pvt. Ltd., of the equipment was found substantially higher than the estimated cost of the equipment and rate reasonability could not be ascertained as per para 7.5.6 of Manual for Procurement of Goods-2017 and Rule 173 (xix) of GFR-2017.
 - (ii) Since provision of GFR rule-2017 cannot be complied, hence, afresh GTE be invited to ensure efficiency, economy, transparency and healthy competition in public procurement.
