

Name of Scheme : **Scheme/Project for safety of women finance from Nirbhaya Fund**

Approved cost: **Rs.38.73 cr. (from 2017-18 to 2019-20)**
Implementing office: **Delhi Police**

Project(1):

Hiring of 60 Professional Counsellors/Social workers at the District, Sub-Division and Police Station level in Delhi Police for providing quality services to the women & children victims at an estimated cost of Rs.5.07 crore.

The principal objective of the project is to recruit and appoint Professional Counsellors/Social workers to give counselling support to the aggrieved women and their families which will further empower them to amicably resolve their cases. Further to establish an effective multi-agency co-ordinated response by the State to all forms of violence against women and children including sexual assault through trained social workers providing quality psycho-socio-legal services for violated women and children. The project is recommended by Empowered Committee of officers under Nirbhaya Fund under Ministry of Women & Child Development and approved by Competent Authority.

Delhi Police has already appointed 60 Social Workers/Counsellors at Sub-Division Level in Districts to extend the counselling services to victims.

Project(2):

New building with women centric facilities for Special Police Unit for Women & Children (SPUWAC) and Special Police unit for North East Region (SPUNER) at Nanakpura, Delhi at an estimated cost of Rs.23.53 crore.

The principal objective of the project is to have a dedicated building for accommodating Special Police Unit for Women & Children (SPUWAC) and Special Police unit for North East Region (SPUNER) and Police Station Crime Against Women Cell (CAW Cell) including facilities for counseling, mediation and gender sensitization and Special Police Unit for North Eastern Region (SPUNER) including facilities for counselling of North Eastern women etc. The project is recommended by Empowered Committee of officers under Nirbhaya Fund under Ministry of Women & Child Development and approved by Competent Authority.

M/s Uttar Pradesh Rajkiya Nirman Nigam Ltd. (UPRNN) has been appointed Consultant-cum-Executing Agency for construction on 21.10.2016.

M/s Tewatia Construction Pvt. Ltd. has been selected by M/s UPRNN for carrying out the construction work of new building for SPUWAC & SPUNER at Nanakpura, New Delhi. Work is likely to commence in first quarter of 2018-19.

Various other activities under scheme for safety of women finance from Nirbhaya Fund

Funds are allocated to Delhi Police for undertaking various activities which are inter alia include holding Camps for Self Defence Training in School/Colleges, Publicity in mass media, procurement of essential items/equipments to enhance the capability of women police force for imparting training, procurement of cyber equipments and making short films/pamphlets on women safety for distribution. An amount of Rs.10.13 crore has been allocated for 3 years i.e. 2017-18 to 2019-20.
