NOTIFICATION

Under Clause (c) of sub-rule (2) of rule 7, read with sub-rule (1) of rule 10 of the NCT of Delhi, Andaman & Nicobar Islands, Lakshadweep, Daman & Diu and Dadra & Nagar Haveli (Civil Service) Rules, 2003, the Joint Secretary (Union Territories) in the Ministry of Home Affairs appoints the following Feeder Grade officers from the Government of NCT of Delhi to the Entry Grade of NCT of Delhi, Andaman & Nicobar Islands, Lakshadweep, Daman & Diu and Dadra & Nagar Haveli Civil Service (DANICS) in the scale of pay of Rs.9,300-34,800/- (Grade Pay Rs.4800/-) on probation for a period of two years with effect from 25th November, 2010, i.e., the date on which their immediate junior i.e., Ram Avatar Doharay was appointed to the Entry Grade of DANICS.
