**NOTIFICATION**

Under Clause (c) of Sub-rule (2) of Rule 7, read with Sub-rule (1) of Rule 10 of the NCT of Delhi, Andaman & Nicobar Islands, Lakshadweep, Daman & Diu and Dadra & Nagar Haveli (Police Service) Rules, 2003, the Joint Secretary (Union Territories) in the Ministry of Home Affairs appoints Mr. Shri Kishan (Date of Birth 01.09.1963) Inspector (D-I/1038) of Delhi Police to the Entry Grade of NCT of Delhi, Andaman & Nicobar Islands, Lakshadweep, Daman & Diu and Dadra & Nagar Haveli Police Service (DANIPS) in the scale of pay of Rs.9,300-34,800/- (Grade Pay Rs.4800/-) on probation for a period of two years with effect from 11<sup>th</sup> November, 2009, i.e., the date on which his immediate junior was appointed to the Entry Grade of DANIPS. His promotion from 11<sup>th</sup> November, 2009 till the date of this order would be only notional and he will not be eligible for back wages. He will be entitled to any other consequential benefits, which may accrue to him under the rules. However, before effecting the said order, the Delhi Police may ensure that he continues to remain free from vigilance angle.

2. The appointment of Mr. Shri Kishan, Inspector of Delhi Police into Entry Grade of DANIPS would be subject to the outcome of CWP No.4210/2007- Jagdish Chand Vs. Union of India and Anr.
