**OFFICE MEMORANDUM**

Sub: **Implementation of recommendations of the Seventh Central Pay Commission regarding grant of Risk and Hardship Allowance to the Personnel of CAPFs and Assam Rifles.**

Consequent upon the acceptance of the recommendations of the 7<sup>th</sup> Central Pay Commission by the Government, vide Ministry of Finance's Resolution No.11-1/2016-IC dated 6<sup>th</sup> July, 2017, the President, in modification of all existing orders issued on the subject from time to time, is pleased to decide that the personnel of Central Armed Police Forces (CAPFs) and Assam Rifles shall be paid Risk and Hardship Allowance as per the rates of newly introduced Risk and Hardship Matrix as under:-

2. Accordingly, based on the above Risk and Hardship Matrix, the Risk and Hardship Allowance to CAPFs & AR personnel will be regulated as under:-

**Note** \* The present system of paying Flying Allowance on an hourly basis to BSF Air Wing is done away with.

3. CI Ops Allowance in Modified Field Areas is presently 77 percent of CI Ops Allowance in Field Areas. This percentage is retained.

4. Modified Field Area Allowance, which is currently at the level of 40 percent of Field Area Allowance, will now be paid at 60 percent of Field Area Allowance, or 60 percent of the rate of this cell (R2 H2).

5. Border Out Posts (BOPs) will be treated as Field Area for the purposes of Risk and Hardship Allowance and will be paid allowance as per R2H2 Cell of above RH Matrix. allowance for the air-maintained BOPs that require a foot march of five days or more will be enhanced by further 25 percent.

6. Regarding Highly Active Field Area Allowance, Field Area Allowance and Modified Field Area Allowance, there is currently conditionality that if an employee posted in such areas proceeds on leave for more than fifteen days, the payment of these allowances is stopped. This ceiling is raised from fifteen days to thirty days.

7. Concurrent admissibility of allowances, applicable to Defence personnel, shall remain unaltered and its applicability will be extended mutatis mutandis to CAPF personnel posted in field areas.

8. As regards classification of Field Areas into Highly Active, Field or Modified, which is presently done by Ministry of Defence, a joint committee of Ministry of Home Affairs and Ministry of Defence will revisit the present classification of places, and future categorizations should also be done as a joint exercise for places where CAPFs are posted.

9. The CAPF personnel will now have the following options to choose from:-

a. Risk and Hardship Allowance (as and where applicable) + Ration Money Allowance.


OR

b. Detachment Allowance + [Special Duty Allowance (as and where applicable) OR Tough Location Allowance (as and where applicable)]

10. The above rates will increase further by 25 percent each time Dearness Allowance rises by 50 percent.

11. These orders shall be effective from 1<sup>st</sup> July, 2017.

12. This issues as per MoF (DoE) Resolution dated 6<sup>th</sup> July 2017, as vetted by the Integrated Finance Division of this Ministry, vide Dy No.3396706/Fin.II/17 dated 31.7.2017.


