Subject: Filling up of three (3) posts of Staff Car Driver (Ordinary Grade) in the Ministry of Home Affairs (Proper) - Regarding.

It is proposed to fill up three (3) posts of Staff Car Driver (Ordinary Grade) in MHA(P) in Level 2 of the Pay Matrix with Basic Pay of Rs. 19900/- (Pay Band of ₹5200-20200 with Grade Pay of ₹1900/- pre-revised) on deputation/absorption basis. **One of the vacant posts is reserved for 'ST' candidate. The vacancy is likely to increase.** The eligibility conditions for recruitment to the post of SCD (Ordinary Grade) are detailed in Annexure-I (enclosed).


2. Applications are invited from regular Dispatch Riders and erstwhile Group 'D' employees (presently Group 'C' employees) who are willing to be considered for appointment as Staff Car Driver (Ordinary Grade). Applications may be sent in the enclosed Proforma (Annexure-II) to Ad-II Section. The application must be routed through proper channel and application in prescribed format shall only be accepted. The sponsoring authorities are requested to forward the application of eligible and interested candidates who can be spared immediately in the event of their selection. While forwarding the applications, photocopies of ACRs for the last 5 years and Vigilance Clearance Certificate of the candidates concerned should also be forwarded. **Last date for receipt of application in Ad-II Section is 31.08.2017. Applications received after the last date and without requisite documents will not be considered.**

ELIGIBILITY CONDITIONS FOR RECRUITMENT TO THE POST OF STAFF CAR DRIVER (ORDINARY GRADE) IN THE MINISTRY OF HOME AFFAIRS (PROPER):

A. Essential:

- (i) Possession of a valid driving license for Motor Cars.
- (ii) Have the knowledge of Motor Mechanism (the candidate should be able to remove minor defects in vehicles).
- (iii) Experience of driving a motor car for at least three years.
- (iv) Pass in 10th Standard from a recognized Board.

B. Desirable

- (i) 3 years service as a Home Guard/Civil Defence Volunteer.

Note: The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not exceed 3 years. **The maximum age limit for deputation is 56 years on the closing date of receipt of application.**
