
ORDER

In continuation of this Ministry's order of even number dated 04.05.2016 appointing Shri Jai Narayan Singh, retired MTS, after his retirement on superannuation on 30.04.2016, as consultant in Ayodhya Section for a period of six months w.e.f. 01.05.2016 to 31.10.2016 and orders dated 29.11.2016 and 28.4.2017 extending his engagement as Consultant for the periods 01.11.16 to 30.04.2017 and 01.05.17 to 31.10.17 respectively, his engagement as Consultant is further extended for a period of another six months w.e.f. 1.11.2017 upto 30.04.2018, or till further orders, in pursuance of Ministry of Home Affairs Admin. II Section's O.M.No. A-42012/11/2015-Ad.II dated 8.6.2015 on hiring of persons on consultancy basis, and concurrence of Admn. Division, vide their note dated 18.10.2017. His assignment is under the provision of the General Financial Rules, 2005 relating to the allocated items of work in the Ayodhya Section.

2. During the period of engagement as consultant, Shri Jai Narayan will be paid the following remuneration:

(a) Last pay drawn (basic)	=Rs.30,200/-
(b) Less Pension	=Rs.15,100/-
(c) Net amount	=Rs.15,100/-
(d) D.A @5% on the basis of revised pay.	=Rs. 755/-
(e) Total Remuneration = (c)+(d) = 15,100 + Rs. 755/- = Rs. 15,855/- per month.	

3. The expenditure is debitable to the head of account "2052 Major Head Secretariat General Services 00.090 Secretariat (Minor Head) 03 Ministry of Home Affairs, 02 General Administration, 03.02.28 Professional Services under Grant No. 46 Ministry of Home Affairs for the year 2017-18".
