
2. The ad-hoc promotions to the grade of UDC will be subject to the following conditions :-

- (i) Ad-hoc promotions will be purely temporary as a stop-gap arrangement and **shall not confer any right** to continue in the grade indefinitely or for inclusion in the Select List for regular appointment or to claim seniority in the UDC's Grade.
- (ii) Ad-hoc arrangement may continue till regular candidates in UDC's Grade become available either through Seniority Quota and/or Limited Departmental Competitive Examination (LDCE).
- (iii) The effective date of ad hoc promotions in respect of those found fit and clear from vigilance angle will be **the date from which the concerned officials join duty in their respective cadres.**
