ORDER

The sanction of the Competent Authority is hereby accorded for engagement of Shri P.K. Biswas, Section Officer (IFD-V), Ministry of Home Affairs as a Consultant in IFD-V Section, Ministry of Home Affairs, North Block with effect from 01.07.2017 to 31.12.2017 or till the posting of a regular incumbent, whichever is earlier.


2. During the period of engagement as Consultant, Shri P.K. Biswas will be paid a fixed remuneration of Rs. 26,652/- per month on the basis of formula {(last pay drawn (pre-revised) -- Rs. 24,340/- (minus) Pension (Rs. 12,170/-) plus DA @ 119% (Rs. 14,482/-)} taking presumptive pay and pension as on 31.12.2015 into consideration, provisionally till a decision is made in the matter of payment of remuneration as per pay revised in accordance with 7th CPC implementation.

3. The terms & conditions of his engagement as consultant will be as follows :-

- (i) During the period of his engagement as consultant, he will report to AFA(Fin/H);
- (ii) Shri Biswas will handle the official files/ matters falling in the official responsibilities of SO(Fin-V) and any other works that may be assigned to him from time to time;
- (iii) His attendance will be recorded by AFA (H) and at the end of every month, it will be sent to Admin. Division for processing his monthly remuneration (as fixed);
- (iv) No leave shall be admissible to him (except closed holidays). In case of need, prior permission of AFA(H)/ Dir(Fin/H) will be obtained by him, which will be subject to adjustment of his remuneration at pro-rata basis.

3. The expenditure is debitable to head of Account: 2052-Secretariat General Services(Major Head), 00.090-Secretariat(Minor Head), 03-Ministry of Home Affairs, 03.02-General Administration, **03.02.28-Professional Services** under Grant No. 46, Ministry of Home Affairs for the year 2017-2018.
