1*[THE JUDICIAL OFFICERS PROTECTION ACT, 1850] ACT NO. 18 OF 1850 [4th April, 1850.] An Act for the protection of Judicial Officers. Preamble.--For the greater protection of Magistrates and others acting judicially. It is enacted as follows:- 1. Non-liability to suit of officers acting judicially, for official acts done in good faith, and of officers executing warrants and orders.--No Judge, Magistrate, Justice of -----
